This is a friendly reminder about an upcoming change to your **automatic (auto pay) premium payment date**.

♥ What to expect

👉 **September 26** will be the new draft date for September auto pay payments.

If you are set up with automatic credit or debit card payments, you **must update your account with your preferred payment method after September 1 and before September 16** to continue automatic payments.

If you are enrolled in auto pay with a **checking or savings account**, no action is needed. Your payment will continue to be processed automatically on September 26.

Going forward, automatic payments will be processed on the 26th of each month. If the 26th falls on a weekend or holiday, your payment will be processed on the next business day.

♥ What you need to do

Action is required if you are enrolled in auto pay with an automatic credit card payment. You **must update your account with your preferred payment method after September 1 and before September 16** to continue automatic payments.

If you are enrolled in auto pay with a **bank account**, no action is needed. Please make sure **funds are available** in your account on September 26 to avoid any issues with your payment.

Important reminder

To keep your health coverage active, your monthly premium must be paid on time. Missing a payment may affect your coverage.

If you have recently turned off auto pay, please disregard this message.
