What is the overall deductible ?	\$0 at Indian Health Care Provider (IHCP) or with IHCP referral at non-IHCP; or In Network: \$6,400/Individual, \$12,800/Family Out of Network: Not Covered	Generally, you must pay all of the costs from providers up to the deductible amount before this plan begins to pay. If you have other family members on the plan , each family member must meet their own individual deductible until the total amount of deductible expenses paid by all family members meets the overall family deductible .
Are there services covered before you meet your deductible ?	Yes. Preventive care/screening /immunization, children's eye exam and glasses, Primary Care, Specialist Care , Urgent Care , Rehabilitation , Habilitation services , Mental/Behavioral Health Office Visits , Preferred generic drugs (Tier 1), Preferred brand drugs (Tier 2), Office visits for routine pregnancy, and Substance Abuse Office Visits do not apply toward the deductible .
